## NOTICE OF PUBLIC HEARING (Board of Supervisors)

NOTICE IS HEREBY GIVEN that the Solano County Board of Supervisors will consider a request that a presently unnamed private easement in four locations be named:

- "Snug Harbor Drive" - Extends southerly from Myer Road East to the south end of Snug Harbor.
- "Marina View Circle" - Extends approximately 350' from the southern end of Snug Harbor Drive northerly for approximately 1150', then easterly until it intersects with Snug Harbor Drive.
- "Port Lane" - Extends easterly between Marina View Circle and Snug Harbor Drive.
- "Starboard Lane" - Extends easterly between Marina View Circle and Snug Harbor Drive.

NOTICE IS HEREBY FURTHER GIVEN that the said Board of Supervisors will consider said request at the hour of 10:00 A.M. on the 2nd day of July, 1985, in the Solano County Courthouse, Fairfield, California, at which time and place any and all persons interested in said matter may appear and be heard.

Dear Property Owner:

The Walnut Grove Post Office which serves you has requested we assign address numbers to replace your present Rural Route 1 and box numbers.

The Solano County Code requires all private roads serving four or more dwellings have official names assigned to them. This is to assist emergency and fire vehicles and any others who need to find a particular address on a private road.

Our records indicate the private road shown on the attached map has never been officially named. We are proposing the private road be named "Smug Harbor Drive".

As a property owner on this private road, we wanted to inform you of this proposal before we present it to the Board of Supervisors for adoption. We expect to go before the Board on June 4, 1985 with a proposal to name this private road. At that time a hearing date will be set. You may make comments at that time if you wish. We will notify you of the time and date of the hearing.

In the next couple of months after this road has been officially named we will notify the post office of your new address that will replace the rural route and box number.

Also once the road is named you have the option of installing a road name sign or the County will perform this service for you upon payment of \$75.
